California National Guard, Fighting Blindness, Hearing Loss, Veterans Crisis Line, Radiological Society, Selective Service, Child Car Seat



Chuck Bentley started by asking the question about paying off credit cards with the smallest balance or the highest interest rate first. According to Kiplinger's magazine the correct answer is to pay off the highest interest rate first. There rationale is that studies show people pay off the smallest balance first. They should pay the minimum on all cards except for the one with the highest interest rate. On that one pay the most you can and when that is paid off do the same for the next highest interest rate card. This approach will allow you to pay a lower interest rate over time which means everything will get paid as cheaply as possible. People seem to feel better about paying off the smallest balance first because it make them feel like they are making progress. Credit cards are expensive and should be used so as not to carry a balance.

David Gibbs stated the question, are churches required to post for their employees the Government Labor Laws on a poster. A church called the Christian Law Association and said they are constantly called by companies saying if they don't buy the Labor Law posters from them they are in violation of the law. The Christian Law Association attorney told the pastor they do not have to buy them, however, every employer including churches are required to post certain labor law information for both Federal and State in a place where the employees can see them. They can download them from both State and Federal employment sites and print them at no charge to the church.

**Chuck Bentley started by asking what do you say when a debt collector calls you.**

**You have plenty of rights thank to the Fair Debt Collection Practices Act. Some**

**helpful tips are to first get the information in writing. Within 5 days of being**

**contacted they must send you in writing who the debt is owed to, the amount of the**

**debt and what action you can take if you do not think you owe the debt. Next if you**

**don't think you owe the money, dispute the debt in writing. If you send a Certified**

**Letter to the collection agency, after receiving information in writing, within 30 days**

**the debt collector can no longer contact you. Next keep a record of all calls,**

**communications and writing from the collector including days and times along with a**

**summary of what was said. There is a lot they cannot do including calling before 8**

**AM or after 9 PM. They cannot call you at work, use abusive language or threaten**

**you in any way. You should know what the Act says.**

**Brief Description:**

Attorney David Gibbs is answering the question of whether or not a designated financial gift given to a church can be used for other purposes. A pastor called the Christian Law Association and asked if a gift like this could be spent in any other way. The answer was that when the church accepts the designated money the church is bound to only spend the money only for that designated purpose. The church is not even allowed to borrow that money for another purpose and later return it for the designated purpose. The only exception is when the church has written into its by-laws that all designated funds are suggestions that are advisory and are not mandatory in nature. Then the church may spend the funds as they see fit and led to do so..
