

**Brief Description:**

Chuck started by saying you need to report on your healthcare arrangements to the IRS. That's one of the consequences of Obamacare. If you don't, it will result in reduced refunds and penalties. Under the Individual Shared Responsibility provision, you must let the IRS know when you file that you have the required healthcare coverage or you are exempt. The IRS has what they call the Premium Tax Credit. That's what the government uses to subsidize healthcare cost. Some people get this credit when they sign up and some will get it when they file their tax returns. On the tax form 8962 you will have answer questions that will affect your return. Such things as divorce, the birth of a child, change in your job or change in your income must be answered. If you claim you need help in paying for your healthcare you had better be right. If you do not have the right coverage you will be subject to a fine and penalty.

David Gibbs started with the question, "are end of the year giving statements necessary". David said a pastor of a small church called the Christian Law Association with several questions about end of year giving statements. One of the attorneys gave him key guidelines to his questions. First, the giver of any gift over \$250.00 must receive a statement from the church for that gift in order to receive a deduction. The IRS does not accept the canceled check as proof of the gift. Second, the statement should absolutely NOT include the givers social security number. The givers name and address is all that is required. Lastly, if the gift is property of any kind, the statement must include a detailed description of the gift but not the dollar value as to amount.

**Brief Description:**

Chuck started by saying Anthem Insurance Company, who is large health insurance company, started warning consumers about a scam email campaign targeting customers and employees to beware of emails offering them credit managing services. These are not coming from Anthem. The reason this is dangerous is that Anthem said their records have been hacked on as many as 80 million current and former customers as well as their employees. The information the scammers have include names, birthdays, social security numbers and income plus other information. These fraudsters can communicate with you just as if they were legitimate. Advice is simple, don't respond in any way to emails like this or open any attachments. Do not respond to phone calls requesting information like this. Anthem has said it would send mail via the Post Office regarding credit monitoring with details about the hack. Chucks advice is not to respond to any request for information without complete assurance it is legitimate. To be on the safe side, call Anthem and speak to an employee who you can verify and talk to them.

**Brief Description:**

David Gibbs told about a church deacon who called the Christian Law Association and asked if it was legal for Illegal Immigrants to become church members. His church has a successful ministry outreach to the Spanish community resulting in many coming to Christ and attending church regularly. The Christian Law Association attorney explained that a person who is in the country illegally may belong to the church. The church along with public schools are not bound to report illegals. They may do volunteer work and help in many ways, however, the church cannot harbor or employ someone in America who is here illegally. The church should not hire illegals for even for odd jobs on the site nor should they allow illegals to reside on church property.
