Facility ID No. 755567 Silent since November 7, 2023 Request for Special Temporary Authority to Remain Silent

Dear Ms. O'Connor:

This letter concerns the request you filed on December 6, 2023, on behalf of Educational Media Foundation (EMF), for Special Temporary Authority (STA) to permit FM Booster Station WKVB-FM1 to remain silent.

EMF's request states that Station WKVB-FM1 went silent on November 7, 2023, for technical reasons.

EMF's request is granted. Accordingly, Special Temporary Authority is granted to permit Station WKVB-FM1 to remain silent not to exceed 180 days from the date of this letter. Notwithstanding the grant of this Special Temporary Authority, the broadcast license for Station WKVB-FM1 will automatically expire as a matter of law if broadcast operations do not resume by 12:01 a.m., November 8, 2024.<sup>1</sup>

EMF is required to notify the Commission when broadcast operations resume.<sup>2</sup> If EMF does not file the notification of resumption of operations in a timely manner, the license may be subject to cancellation pursuant to section 312(g) of the Communications Act, as amended.<sup>3</sup>

The station's silent status does not suspend the licensee's obligation to comply with all other relevant Commission rules, including the filing, when appropriate, of applications for renewal of

broadcast license. In the event of license cancellation, it is imperative to the safety of air navigation that any prescribed painting and illumination of the station's tower shall be maintained until removed.<sup>4</sup>
