On behalf of Best Broadcasting, Inc. (“Best Broadcasting”), licensee of AM station KFMZ, we hereby respond to the Federal Communications Commission’s (“FCC” or “Commission”) October 30, 2023 Public Notice and letter (together “letter”) identifying radio station KFMZ as being randomly selected for audit of its EEO Program.

Radio station KFMZ, FCC Facility ID No. 2, Brookfield, MO is one of two radio stations in its employment unit (“EU”). The other station in Best Broadcasting’s EU is KZBK (FM), FCC Facility No. 4930, licensed for Brookfield, MO. Best Broadcasting’s EU currently employs 1 full-time employee.

Each request for information is addressed in the order as set out in the Commission’s letter:



Paragraph 2(b)(vi): This EU is not aware of any complaints alleging unlawful discrimination on the basis of race, color, religion, national origin or sex during its current license term.


