And with Bloomberg's proposal in mind to extend the 7 train out to Secaucus, NJ, Previdi believes that we may have reached a fair agreement. Although, Previdi proposes that the Transit Authority extend the tunnel to Hoboken, NJ rather than to Secaucus. This would cost taxpayers far less while also shortening the distance between NYC and NJ. The project must be done and it will be soon - but now is the time when officials are sorting out the details.

Since its founding, they have rescued over 6,500 stray and abandoned pets. Without JAC's intervention, these animals would most likely have been euthanized in pounds or left to die on the streets. The mission of JAC is simply to preserve life. JAC holds an Adoption Day at regular intervals at the JAC shelter, in addition to various ongoing events. JAC promotes spay/neuter, reunite owners with their lost pets, and educates the public about responsible pet ownership. They have also established various special programs and funds for seriously injured, abused, or otherwise disadvantaged pets.

Gregg joined us again on the program this year as we draw closer to the deadline to encourage listeners to get that early jump on their taxes to prevent the last minute crunch we so often see. He stressed the importance of gathering records early and to seek help from the IRS website for any questions and concerns. 1040 Central is the web page that provides organized information and trouble-free tax filing, the alternative to waiting in line at a local branch of the IRS. Semanick also mentioned the most common problems that occur for filers such as math errors, not signing the return or putting the social security number on the form. To help eliminate these problems, Gregg encourages e-filing, the major proponent used by the IRS. E-filers can take advantage of this free service to help eliminate confusion and incidental mistakes that can delay processing time.
