- A total of six times. At least once a day on the first and sixteenth day of the month that the application is filed (June) and of the next two months thereafter (July & August). At least three of the six announcements must be broadcast between 6:00 p.m. and 11:00 p.m. ET/PT (or 5:00 p.m.- 10:00 p.m. CT/MT). Of the remaining three post-filing announcements, one should be broadcast between 9:00 a.m. and 1:00 p.m., one between 1:00 p.m. and 5:00 p.m., and one between 5:00 p.m. and 7:00 p.m.— regardless of time zone.
- When a renewal application is filed after the first of the month because, for example, the first of the month is
 on a weekend, the first post-filing announcement should air on the same day that the license renewal
 application is filed.
- Stations broadcasting in a foreign language should broadcast the announcements in that language.
- Stations that cannot broadcast this announcement because they are off the air should publish the text of the
 announcement in a daily, weekly, or bi-weekly newspaper of general circulation in the community to be
 served.
