The lurid nature of the case and Chmura's celebrity status has combined to make the ex-Packer's sexual assault trial mega-news for local media. Local TV stations will be in court every day and there's even some talk of live coverage of Chmura's expected testimony. And yes, Court TV is expected to be here too. Is all of this any way to try to find justice... Mordecai Lee?

The biggest star on the Baltimore Raven's team that plays this afternoon, Ray Lewis, was convicted only of a misdemeanor obstruction charge after initially being accused of murder one year ago. Only last weekend another jury refused to convict football star Rae Carruth of murdering the woman pregnant with his child, even though the evidence against Carruth was overwhelming. [Guests: Jeff Pawlinski & Alberta Darling] "CHILLING EFFECT" That's what some advocates for sexual assault victims say will be the result of the Mark Chmura trial and his acquittal. The way the public meat grinder that Chmura's teenager accuser was put through will lead many rape victims in the future to think twice about reporting the attacks against them. Is this a legitimate concern or does a defendant's right to confront his accuser make aggressive questioning necessary, Joel McNally? Chmura's win is raising a lot of questions about the aggressive tactics used by Waukesha County District Attorney Paul Bucher. Some are saying he overcharged Chmura and others are questioning his pressuring of defense witness Michael Kleber. Bucher is known to have big ambitions. He has been considered a front runner to become the new United States Attorney for Eastern Wisconsin or if he doesn't get that job, a candidate for Wisconsin Attorney General in next year's election. Does his courtroom loss diminish Bucher's future star power, J.J. Blonien? Now let's talk about the public reaction. When Chmura's "Not Guilty" verdicts were announced patrons in taverns cheered and whooped it up. The following day autograph seekers attended a Chmura News Conference. All of this "hero worshipping" a guy who himself admitted to bad judgment in his boozing it up at a Prom party have taken some people aback. Is the public celebration of Chmura's win justifiable... "SEARCH AND YE SHALL FIND" Here's another case that shows just how deeply divided Wisconsin's State Supreme Court is. A State Trooper in the Stevens Point area pulled over a van that was missing a front license plate. The Trooper asked the driver if anything illegal was in the car. The driver said no. The Trooper asked if he could check. The Trooper went through among other things a jacket belonging to the driver's passenger. He found marijuana and LSD in a pocket. The passenger's lawyer tried to suppress the drug evidence claiming the driver doesn't have power to allow a search of a passenger's jacket. The State's top court disagreed on a 4-3 verdict, with the conservatives okaying the search and the liberals opposing it. Curiously there is no precedent dealing with this type of search from the U.S. Supreme Court. Was the Court's ruling correct... Joel McNally?

Kevin Perlsberg had two extra tickets that he was attempting to sell at a loss when Milwaukee Police handcuffed him and took him to jail for eight hours. Laws prohibit people from re-selling tickets within 500' of a sports or concert venue and an even more strict distance at Miller Park at 750'. However it has long been the custom at the Bradley Center to leave ticket sellers alone if they simply stayed across the Street. Does Perlsberg have a legitimate gripe or not, Mordecai Lee?

[Guests: Jeff Pawlinski & Joel McNally] "THE JUDGE PLEADS GUILTY" Wisconsin Supreme Court Justice Jon Wilcox is agreeing to pay a \$10,000 fine to settle a long battle over attacks that political mailings were linked to his successful 1997 re-election campaign. The State Elections Board contended Wilcox broke the law by allowing his campaign to cooperate with a supposedly independent group that had been attacking Wilcox' election opponent Walt Kelly. Election laws prohibit coordination of efforts between the candidate's campaigns and independent groups that are free from most regulation. Is the \$10,000 fine sufficient punishment or is Wilcox getting off too easily, Joel McNally?

[Guests: Matt Flynn & Nancy Chandler] "MARILYN'S STORY AND IT'S NOT PRETTY" Milwaukee Mayor John Norquist's sexual harassment accuser has given her first interview and it is an almost shocking description of the relationship best described as a stalking. Figueroa's interview in Milwaukee Magazine says Norquist used his status as Figueroa's boss to relentlessly pursue her and pressure her into having sex approximately ten times. In one instance, Figueroa describes what could fairly be called a rape and the Magazine reports the incident as if it were an unchallenged fact. "He moved toward her and pinned her against the staircase. Figueroa says she pleaded with him to stop. He apologized and begged her not to leave. She was protesting and struggling as he pulled her to the sofa, grabbed her forearm, pushed her onto her back and forced himself into her. He was holding her down so strongly Marilyn says she couldn't free herself." Norquist declined to be interviewed for the story, but since its publication has fired back with shots of his own. The Mayor's attorney, Anne Shindell, says it was Figueroa that initiated a consensual relationship and tried to keep it going by inviting Norquist to her home and greeting him while wearing only a negligee. Clearly, someone is lying. If Marilyn Figueroa is telling the truth. Should John Norquist be serving as Milwaukee's Mayor, Nancy Chandler?

"THE D.A. AND THE DNA" A tactic developed by the Office of Milwaukee County District Attorney Mike McCann is being picked up by prosecutors in other cities, and a test of its legality may soon wind up in the U.S. Supreme Court. McCann has been attempting to get around the statute of limitations in rape cases by filing charges against unknown defendants identified by their DNA. One of those cases has resulted in an actual prosecution with the charging of this week of Bobby Dabney, Jr. in connection with a 1994 rape. Dabney's DNA has been matched to that found after a rape of a Milwaukee woman in 1994. Prosecutors filed criminal charges against the unnamed John Doe in December, right before the statute of limitations was to expire. Is this a justifiable tactic to convict criminals or a flouting of the statute of limitations, J.J. Blonien?

Several other United Way groups around the country have already de-funded the Scouts because of the organization's refusal to allow openly gay Scouts or Scoutmasters to participate in the organization. The United Way recently concluded its Milwaukee area fund-drive, raising nearly \$30,000,000 but won't decide until Spring how the money is allocated. 24% of the money raised by the Milwaukee area Boy Scouts, \$668,000 comes from the United Way. Should the Boy Scouts be cut-off, State Representative Scott Walker ?

City documents show the buyer of Northridge Shopping Center paid only \$3.5 million for the struggling Mall. The value of Northridge has fallen faster than most dot.com stocks. The Mall was valued at \$63 million only three years ago. Last year, a deal to sell it for \$18 million fell through. Now the Mall is essentially being given away.

In the meantime, smaller empty lots nearby Northridge are selling for more money. The Real Estate Market seems to saying Northridge would be worth more as a vacant lot than as a shopping mall. How did this happen so fast... Mordecai Lee?
