Dear Director Shears:

The undersigned, an officer of Citicasters Co. ("Citicasters"), hereby submits this update to the January 7, 2013 response ("Response") to the above-referenced Notice of Violations regarding the three antenna structures that make up the transmitting array of AM broadcast station KCOL, Wellington, Colorado (FCC Facility ID No. 68685).

Citicasters noted in the Response that the lighting configurations for Antenna Structures # 1034534, # 1034535 and # 1034536 (one flashing beacon at the top of each tower and two sidelights at the one-third and two-third levels of each tower) is consistent with the lighting specifications on the KCOL license. Specifically, the KCOL license incorporates Paragraphs 1, 3, 12 and 21 of Form 715, "Obstruction Marking and Lighting Specifications."

Citicasters noted that to the extent that the Antenna Structure Registrations ("ASRs") for the KCOL towers referenced FAA Circular 70/7460-1J for Nikki P. Shears

tower lighting specifications, such cross-reference was an administrative error and that Citicasters would request that the subject ASRs be corrected to appropriately reference the KCOL license lighting specifications and would update the Denver District Office upon such correction.

This update is to report that the FCC's Wireless Bureau has corrected the ASRs for the KCOL towers to eliminate the references to FAA Circular 70/7460-1J and to instead properly reference Paragraphs 1, 3, 12 and 21 of Form 715. Reference copies from the Wireless Bureau of the revised ASRs, which now incorporate Paragraphs 1, 3, 12 and 21 (and on page 3, include the text of those Paragraphs), are attached. Consequently, as explained in the Response, the lighting configurations for Antenna Structures # 1034534, # 1034535 and # 1034536 are not in violation of 47 C.F.R. Section 17.23.
