Dear Ms. Goldin,

Cumulus Licensing LLC (“Cumulus”) is the licensee of Station KWYE(FM), Fresno, California (Fac. ID No. 18406), which appeared on the list associated with the August 6, 2021, FCC Public Notice that identified stations randomly selected for an EEO audit. KWYE(FM) is part of a Fresno, California station employment unit (“SEU”) with commonly-owned stations KSKS(FM), KMJ(AM), KMJ-FM, and KMGV(FM), all also located in Fresno, California.

By way of this email, Cumulus respectfully requests an extension of time to respond to the FCC’s August 6, 2021 EEO Audit Letter (“Letter”). Assembling an EEO audit response during the pandemic continues to be challenging. Cumulus has not yet required its employees to return to the office, which has had a significant impact on this SEU’s ability to compile the documents necessary to complete its response to the Letter. We are told that Cumulus expects to allow employees to return to their offices on or about October 11, 2021, provided they are vaccinated. Further, the member of its outside communications counsel responsible for “overseeing” eight EEO audits continues to deal with a serious family emergency and cannot devote the requisite amount of time and attention to all of them between now and September 20, 2021. In order to assemble the documentation requested in the Letter and present a well-organized and thorough response, Cumulus respectfully requests an extension of time until October, 30, 2021 to complete its reply.
