Mr. Pulley,

Cumulus Licensing LLC ("Cumulus") is the licensee of Station KMJ(AM), Fresno, California, which was included on the list associated with the February 6, 2020, FCC Public Notice that identified stations subject to a random EEO audit. KMJ is part of a station employment unit ("SEU" or "Unit") with commonly-owned stations KSKS(FM), KMJ-FM, KMGV(FM), and KWYE(FM), all also located in Fresno, California.

In an earlier email, you consented to an extension of time until April 30, 2020, for the Unit to submit its response to the February 6, 2020, FCC EEO Audit Letter ("the Letter"). Due to unexpected circumstances that have occurred since the earlier request was submitted, Cumulus respectfully asks for a further extension of time to respond to the Letter. The outbreak of the Coronavirus made it necessary for Cumulus to require all of its employees to stay away from its offices and work from home. Needless to say, this had a significant impact on the Unit's ability to gain access to documents which would enable the SEU to complete its response to the Letter. In addition, all but the essential Cumulus employees have been furloughed, some for ninety days and some for an intermittent, three week period. Although each market has coordinated the furloughs so that not all the employees are on furlough at the same time, when employees are absent, the remaining employees are expected to take on extra duties. Furthermore, counsel is also homebound and lacks the means to assist with the assembling of a well-organized and thorough response to the Letter. For these reasons, Cumulus respectfully requests an extension of time, until June 5, 2020, to complete its reply.
