Subject: Cumulus Licensing LLC - Fresno, CA SEU - Request for Extension of Time

Good evening, Mr. Pulley -

Cumulus Licensing LLC (“Cumulus”) is the licensee of Station KMJ(AM), Fresno, California, which was included on the list associated with the February 6, 2020, FCC Public Notice that identified stations subject to a random EEO audit. KMJ is part of a station employment unit (“SEU”) with commonly-owned stations KSKS(FM), KMJ-FM, KMGV(FM), and KWYE(FM), all also located in Fresno, California. Cumulus respectfully requests an extension of time to respond to the February 6, 2020, EEO Audit Letter (“the Letter”). This SEU, as well as other Cumulus SEUs, is in the process of preparing a detailed response to a FCC Media Bureau investigation, which is due at the end of March 2020. This unexpected and time consuming project coupled with the responsibilities of the day-to-day operation of the Fresno stations has stretched resources quite thin. This has been further exacerbated by the outbreak of the Coronavirus. Currently, most of the Cumulus SEUs have only essential personnel on site. As a result and understandably, the SEU has been unable to direct its focus on formulating its response to the Letter. In order to assemble the documentation requested in the Letter and prepare a thorough response, CMP respectfully requests an extension of time, until April 30, 2020, to complete its reply.
