Section I. Issues

The stations have identified the following topics as significant issues facing our community in this quarter:

- **Motor Vehicle Theft/Burglary Crisis:** Before Bail Reform was enacted by New Jersey Governor Phil Murphy and certain state lawmakers in 2017, Monmouth County averaged under 185 car thefts per year. In 2018 it went up to 240 overall, in 2019 it was 300, in 2020 it was 320 and in 2022 alone it was more than 580. Sheriff Shaun Golden has continued to pitch solutions to the state to fix this problem and pleads to keep certain re-offenders in jail until their detention hearing or trial.
- **Food Insecurity:** The number of people who have been using food pantries in Ocean County and Monmouth County between just January and June of 2022 went up by 60 percent and it stayed the same or got worse than that to close out the year.
- **Jersey Shore Environment:** Many environmentalists and certain New Jersey lawmakers have advocated for a full-court press of changes turning away from gas and going to electric energy among other changes. The idea of Offshore Wind Farms is being met with concern and opposition in Ocean County, but, for different environmental reasons.
- **Mental Health:** The stigma associated with mental health has become more of an issue in Ocean County and Monmouth County since the pandemic began. There is a continued call for action to help those struggling find help without judgment.
- **New Jersey Elections:** The highly contested and publicized mid-term elections made their mark in Monmouth County and Ocean County in 2022 and not just because of the failing grades and unpopularity of the President but growing frustration and concern among the middle class in New Jersey facing the highest state taxes in the county during a time of rising inflation and gas prices. Monmouth County Clerk Christine Hanlon details the process of how voting takes place and what people need to know.
