On behalf of Granite Broadcasting Corporation ("Broadcaster"), we are providing AT&T Services, Inc. ("Operator") with this notice pursuant to Section 325 of the Communications Act of 1934, as amended, and Section 76.64(f) of the Rules and Regulations of the Federal Communications Commission.
