
Dear Ladies and Gentlemen:

On behalf of Granite Broadcasting Corporation (“Broadcaster”), we are providing Verizon Corporate Services Group Inc. (“Operator”) with this notice pursuant to Section 325 of the Communications Act of 1934, as amended, and Section 76.64(f) of the Rules and Regulations of the Federal Communications Commission.
