

Payment for radio advertising purchased from STATIONS and funded by cooperative or vendor sources is the sole responsibility of the undersigned advertiser. All checks returned for nonpayment are subject to a \$25 fee to be paid by the party whose check was returned. Additionally, if paying by check I authorize the radio stations either to use the information from my check to make a one time electronic transfer from my account, or to process the payment as a check transaction. When we use this information from your check to make an electronic fund transfer, funds may be withdrawn from your account as soon as the same day you make your payment, and you will not receive your check back from your financial institution. In the event that your check is returned unpaid for insufficient or uncollected funds, we may electronically debit your account for the principal amount of the check. Any changes to this Agreement must be presented in writing to STATIONS at least two (2) weeks before the proposed change. The advertiser is responsible for all sums owing as a result of any change. Proposed changes are subject to the approval of STATIONS. Special Package Rates are non-cancel-able. In the event an advertiser cancels an Agreement, Advertiser will be responsible for the difference between rate card and the negotiated contract spot rate (Short Rate) for any advertising that has previously aired within the dates of said contract.
