FM BROADCAST STATION LICENSE

is hereby authorized to use and operate the radio transmitting apparatus hereinafter described for the purpose of broadcasting for the term ending 3 a.m. Local Time: DECEMBER 1, 1989

The licensee shall use and operate said apparatus only in accordance with the following terms:
