ORDER GRANTING RECEIVER'S MOTION TO PRELIMINARILY CONFIRM RECEIVER'S SALE

This matter comes before the Court on January 20, 2021, on the Receiver's Motion to Preliminarily Confirm Receiver's Sale (the "Motion"). The Receiver, Ronald Metzinger, appears by his counsel of record, W. Thomas Gilman of Hinkle Law Firm LLC. The plaintiff, Central Plains Finance, LLC, appears by its counsel of record, Shannon D. Wead of Foulston Siefkin LLP. Christopher Miller, appears by counsel, Travis J. Ternes of Watkins Calcara, Chtd.

WHEREUPON, the Court finds:

1. The Receiver's judicial sale was conducted in the above matter on January 5, 2021, pursuant to the Journal Entry of Judgment filed herein on October 20, 2020, the Order of Sale filed herein on November 6, 2020, and the Order of Instructions for the

Receiver to Conduct Foreclosure Sale filed herein on November 19, 2020. The Receiver sold the following described real and personal property owned by the defendant, Southwind Broadcasting LLC ("Southwind"). The Personal Property, Fixtures and Real Property described below, together, are referred to herein as the "Property."

- 2. The Property was sold to Central Plains Finance, LLC, the only and highest bidder, for \$2,567,658.85, the full amount of Central Plains' judgment with costs, fees, and interest accrued through the date of sale.
- 3. The sale was conducted in accordance with applicable law and the orders of this Court.
- 4. The Motion sought an order confirming the sale on a preliminary basis pending the FCC's authorization to assign applicable FCC licenses associated with the Property and the broadcasting business conducted upon and with the Property. Upon FCC approval, the Receiver shall seek a final order confirming the sale. If the FCC does not approve the assignment of the FCC licenses to Central Plains Finance, LLC, the sale will not be confirmed on a final basis.
- 5. The licenses pursuant to which Southwind Broadcasting, LLC's radio broadcast business operates (collectively, the "FCC Authorizations") were not part of the Central Plains Finance, LLC's collateral, but the proceeds from the sale of the FCC Authorizations are part of the Central Plains Finance, LLC's collateral. Accordingly, the consummation of the sale of the Property, and the assignment of the FCC Authorizations by the Receiver is contingent on, and subject to, the FCC approving the transfer of the FCC Authorizations to Central Plains Finance, LLC as the highest bidder at the sale. No provision of the Motion or any order granting this Motion shall relieve Central Plains

Finance, LLC from obligations to comply with the Communications Act of 1934, as

amended, and the rules, regulations, and orders promulgated thereunder by the FCC,

and no assignment or transfer of control of any federal license or authorization issued by

the FCC shall take place prior to the issuance of FCC regulatory approval for such

assignment or transfer pursuant to applicable FCC regulations. The FCC's rights and

powers to take any action pursuant to its regulatory authority over the assignment or

transfer of the FCC Authorization to Central Plains Finance, LLC, including but not

limited to imposing any regulatory conditions on any such transfer or assignment, are

fully preserved, and nothing in the case shall proscribe or constrain the FCC's exercise of

Multiple Ownership Study Central Plains Finance, LLC February 6, 2021

I conducted the following study of local radio ownership compliance in connection with an application for consent of the Federal Communications Commission (the "Commission") to the assignment to Central Plains Finance, LLC ("Central Plains") of the broadcast licenses for the following eight (8) full-service commercial radio stations subject to a Kansas state receivership proceeding and licensed to Southwind Broadcasting, LLC, under Ron Metzinger, Receiver. (the "Southwind Receivership")

KULY(AM), Ulysses, KS (Facility Id. No. 198) KHGN(FM), Hugoton, KS (Facility Id. No. 199) KBUF(AM), Holcomb, KS (Facility Id. No. 33689) KKJQ(FM), Garden City, KS (Facility Id. No. 33690) KSKZ(FM), Copeland, KS (Facility Id. No. 60873) KWKR(FM), Leoti, KS (Facility Id. No. 67042) KSKL(FM), Scott City, KS (Facility Id. No. 71853) KSSA(FM), Ingalls, KS (Facility Id. No. 77873)

The eight Southwind stations are still in compliance with the Commission Part 73.3555 Rules concerning cognizable ownership in an unrated radio market.

The proposed assignee, Central Plains, is wholly owned and controlled by Murfin, Inc., which also controls My Town Media, Inc. ("My Town") and Post-Rock Radio, LLC ("Post Rock"), each a broadcast licensee.

My Town Media, Inc. ("My Town") is the licensee of the following full-service radio broadcast stations:

Only three of the stations licensed to My Town or Post Rock are sufficiently close to one or more of the Southwind Receivership stations to warrant study for possible overlap of principal community contours:

KKDT(FM), Burdett, KS (Facilities Id. No.164130) KXNC(FM), Ness City, KS (Facilities Id. No. 154131) KQZQ(FM), Kiowa, KS (Facilities Id. No.164275)

I found no overlap of the principal community contours of these three stations into the principal community contours of any of the eight Southwind Receivership stations. The closest spacing of contours found was 16.8 kilometers separation between the contours of KKDT and KKJQ. This was on the KKDT 215.5 degree radial. The next closest spacing was on the KKDT 264.7 degree radial, with a separation of 26 kilometers away from the KSLK contour. The separation between the city grade 5.0 mv/m contour of AM station KBUF and KKDT was calculated at 30.7 kilometers, on the KKDT 236.8 degree radial. KQZQ is located 171.17 kilometers from the nearest Southwind stations, KKJQ, KSSA and KSKZ. There is a 43.1 kilometer separation between the contour of KQZQ and KKJQ.

No Southwind Receivership station is licensed to a community within a Nielsen Audio market. For combinations that are licensed to communities that are not home to any Nielsen Audio market, the Commission defines the market as the area where the principal community contours of the commonly owned stations overlap. To determine the number of stations in that market, the Commission counts all stations whose principal community contours (3.16 mV/m) overlap that of at least one of the commonly owned stations. The Commission, however, excludes all stations whose transmitters are greater than 92 kilometers from the mutual overlap area and any commonly owned stations that are not included already in the market. The attached Southwind stations contour map shows five areas of overlap of the city grade contours. None of these overlap or cluster areas have more than five commercial radio stations and not more than three commercial stations with the same AM or FM modulation.

I also determined that the eight Southwind Receivership stations themselves may continue to be held by a single entity consistent with the Commission's Contour Methodology. A contour study map showing the coverage of the Southwind stations is attached to this study. There have been no changes in the contours of the Southwind stations and no addition of Southwest radio stations in the five very rural Kansas contour areas since a Southwind Multiple Ownership study was submitted to the Commission on March 13, 2018. Since then also there have been no changes in the contours of those independently owned stations that established market size sufficient to show compliance in each market.

Mr. William Wachter, an attributable principal of My Town and of Post Rock (but not of Central Plains or of Murfin, Inc.), also is an attributable principal of One Media, Inc., licensee of the following full-service radio broadcast stations:

KMML(FM), Cimarron, KS (Facilities Id. No. 164238) KRZD(AM), Springfield, MO (Facilities Id. No. 17137) KSHQ(FM), Deerfield, MO (Facilities Id. No.190419) KWKN(FM), WaKeeney, KS (Facilities Id. No.190424)

The KMML(FM) Cimarron, Kansas station tower is located only 22.17 kilometers from the joint KKJQ(FM), KSSA(FM) and KSKZ(FM) Southwind tower. KWKN(FM) in WaKeeney, Kansas is located 169.05 kilometers from the nearest Southwind station, KSKL(FM) in Scott City, Kansas. KRZD(AM) and KSHQ(FM) are both located east, in the state of Missouri. With the exception of KMML(FM), there will be no overlap of city grade contours.

Mr. Robert Young, an attributable principal of Murfin, Inc., parent entity of Central Plains, is the licensee of the following full-service broadcast stations:

KBZI(FM), Moorland, OK (Facility Id. No. 191542 KDHL(FM), Americus, KS (Facility Id. No. 191544

KBZI in Moorland, Oklahoma is located 164.98 kilometers from the joint KKJQ(FM) tower site. KDHL(FM) is located in Americus, in eastern Kansas, 376.81 kilometers distant from the joint tower site. There will be no overlap of city grade contours.

Included with this report are site maps of the stations studied, along with maps showing the principal community contours. The contour data for all the stations is also attached to the report. In summary, because the Southwind Receivership stations are outside of all Nielsen Audio markets, the Commission's contour methodology determines compliance with the applicable local radio ownership ceilings. No Southwind Receivership station has any overlap of its principal community contours with any of the full-service radio broadcast stations held by licensees commonly owned with Central Plains. Accordingly, the proposed acquisition of the Southwind Receivership stations by Central Plains would not create any new radio combinations to which the Commission's local ownership limitations would apply and complies with the Commission's local radio ownership rules.


