Problem # 2: *Scambuster: New Twist On Email Phishing Scam*

Scammers have found a new way to spread viruses—and it deals with your email.

Used to, a scammer would just hack your email and send emails to everyone in your contacts list with viruses embedded into them.— and it was pretty easy to tell the email was a scam. But now, scammers have taken it up a level.

Once they hack your email, they find one you've already sent that includes an attachment and they make some modifications.

It's not the attachment anymore, they have removed the attachment, named it what it was before, and it's now taking you to a login page for a specific account, it could be Google, Yahoo, or another account.

Then they send out the email again. Scammers think you'll open it again because after all, you've opened this email before. Except now when it takes you to that page and you log in, you are releasing the virus onto your computer.

The virus can lock you completely down, it can slow things down, or it can steal information.

A few tips: Don't open an email you've already gotten, or call the person who sent it and ask if they sent it again. If you do click on the attachment and it takes you to a login page, don't enter any information and disconnect your computer from the internet immediately.

Problem # 3: *Making Taxes Less Taxing*

On this edition of My Money Life from Crown Financial, Chuck Bentley discussed ways to make filing taxes a little less stressful.

Most of us will file our tax returns. To make your tax experience less painful more productive and hopefully rewarding, Chuck assembled a few tips for you.

First of all be honest. Never give false information or numbers you can't support with documentation. Honesty allows you to file without fear and to sleep well at night.

Also organize your documents. Have your W2's from employer's or your 1099s from contract work all in one place. You need your vehicle registration fees charitable contributions medical expenses sales tax receipts and other files documenting things like a move or job search expenses that you'll need to assemble. Avoid the cost of lost time and money by spending a little time getting your paperwork together. If you're unsure about filing yourself, then go to irs.gov. Do some research or hire someone to do it for you. It's better to be right than sorry. Also filing online is faster, safer and secure. The IRS has approved a number of companies. And don't rush. One of the top mistakes taxpayers make when trying to meet the deadline is recording incorrect Social Security numbers for their children and spouses.

Slow down, review your work and ask someone else to double-check it for you. Following these few steps can help make filing your taxes less taxing.

Problem # 4: *Alabama's Jobless Rate Rises To 6.4 Percent*

Alabama's unemployment rate is up to 6.4 percent despite improvement in the national jobless picture.

The state released statistics Monday showing the January rate was up one-tenth of a percent from the December rate of 6.3 percent. It was also well above the year-ago rate of 6.1 percent.

Nationally, unemployment dropped to 4.7 percent in figures released last week.

State unemployment is rising because people are entering Alabama's workforce faster than jobs are being created and filled.

In Mobile County, an alarming rise in just one month. During Jan. 2017, the unemployment rate was 8.1 percent, which is up from 7.1 percent in Dec. 2016. It was much of the same picture in Baldwin County where the rate rose to 6.4 percent from 5.6 percent.

Problem # 6: *Tax Free Weekend For Weather Preparedness Products*

You may not know it, but it's a severe weather tax-free weekend in Alabama. Items that are used to prepare for hurricanes or tornadoes will be tax-free today through Sunday.

This includes items like batteries, tape, bungee cords, tarps, coolers and plywood. Many hardware stores and even sporting goods stores that carry camping gear will have tax free items. Each item must be less than 60 dollars to get it tax free. Generators are the only exception to that price cap.
