According to Driscoll and the National Retail Federation 80 percent of consumers prefer to make returns and exchanges in stores, and 74 percent indicate they are likely to purchase something else while returning or exchanging an unwanted gift. Whether in person or online, Driscoll said it is important to understand retailer terms, conditions, policies, and time frames for returns. The BBB spokesperson says unless an item is defective or misrepresented, a retailer isn't necessarily obligated to process a return. She gave some return tips, know the seller's policies, understand warranties, keep all packaging, be aware of potential restocking and shipping fees. Gazarik says after Prohibition was repealed, residents became the hardest drinkers in the state. By 1937 residents spent \$15.5-Million a year on liquor. The author says Western Pennsylvania still has a reputation as FORBES magazine rates Pittsburgh as eleventh out of 15 hard-drinking cities in the US. The practices may lead to financial loss or being at risk for identity theft. Driscoll says you should contact a legitimate technical support company you know and can trust. COVID-19, or Coronavirus has put a strain on our society with restrictions the government and Centers for Disease Control have placed on us. Most non-essential businesses have been forced to either reduce operations or close – entertainment and sporting complexes, shopping malls, retail facilities, barber shops and hair salons. Grocery stores have cut hours and restaurants may only serve take out or drive thru orders. Churches are forced to offer web streamed services or cancel altogether. This is having a secondary impact on blood donations as many places where drives have historically been hosted are unable to keep their events going.
