WPNA 103.1 FM Programs Addressing Public and Community Issues

During the fourth quarter of 2023, WPNA's bilingual (Polish/English) locally produced programming addressed the following issues of concern to the public:

1. *Afternoon with 103.1 FM* (October 9, 4:30 p.m., segment duration 12:14)

Issue of concern: Medical studies abroad

Afternoon hosts interviewed representatives of the Medical University of Poznan, Poland, including Prof. Lukasz Gasiorowski, Vice-Director for Admissions and International Cooperation, who presented the options for attending the school as a foreign student.

2. *Morning with 103.1 FM* (October 23, 8:00 a.m., segment duration 5 min.)

Issue of concern: Polish Film Festival in America

Morning show hosts discussed the upcoming Polish Film Festival in America, the annual showcase of Polish film outside of Poland, to be held in November. The festival program highlights were summarized for the listeners.

3. Afternoon with 103.1 FM (October 26, 4:00 p.m., segment duration 6 min.)

Issue of concern: Polish Independence celebrations abroad

Afternoon hosts discussed the upcoming Polish Independence 10K/5K Run/Walk, commemorating the anniversary of Poland regaining independence, and the ways the station listeners can participate in the event. Other commemorative events and their programs were discussed with information on how to participate.

4. Evening with 103.1 FM (November 9, 6:30 p.m., segment duration 11:15)

Issue of concern: 2022 Second Installment Tax Bill

As homeowners in Cook County receive their 2022 Second Installment Tax Bill in the mail, they are encouraged to look at the bottom left corner to ensure they are receiving their property tax savings. Homeowners who are missing their property tax savings can apply for them via a Certificate of Error application at the Cook County Assessor's Office. Mateusz Pankiewicz was joined on air by Cook County Assessor Fritz Kaegi, to help the listeners find out more information about the upcoming tax season and how to apply for the property tax savings.

5. Afternoon with 103.1 FM (December 14, 5:00 p.m., segment duration 8:08)

Issue of concern: Help for homeless and abused mothers

Afternoon hosts interviewed Sister Marta Cichoń of The Missionary Sisters of Christ the King, the founder and principal of the Holy Family Single Mothers' House in Chicago and of the Totus Tuus Foundation. The Totus Tuus Foundation provides housing for homeless mothers often running away from abusive relationships. They get support with education and career training, as well as assistance finding employment. And when they are ready, the women receive help in getting a place of their own and basic furnishings. Sister Marta is tirelessly searching for donations and manages to find sponsors for the immediate needs of the women and children under her care.
