
Dear Ms. MacKenzie:

("Licensee"), licensee of television station WTNH-TV, New Haven, Connecticut (the "Station"), located in the Hartford-New Haven, Connecticut DMA, hereby gives notice to Comcast Cable Communications, LLC that pursuant to Section 325(b)(3)(B) of the Communications Act and Section 76.64(f)(2) of the FCC's Rules, Licensee elects to assert its right, under Section 325(b)(1)(A) of the 1992 Act and Section 76.64(a) of the FCC's rules, to have the broadcast signal of the Station carried on cable systems only if we have provided our express written consent. 
