#### BROADCAST ORDER TERMS AND CONDITIONS

The organization contracting for broadcast time covered by this contract ("AGENCY") and the station accepting this contract ("STATION") hereby agree that this contract shall be governed by

#### PAYMENT AND BILLING

- (a) STATION will bill AGENCY monthly using the Final Sunday Fiscal Month or within five (5) days after the end of this contract

- (e) in the event AGENCY is not an advertising agency or person, firm or corporation which authorizes AGENCY to contract for broadcast time hereunder shall be liable in

# EFFECT OF BREACH

Upon such cancellation, all charges for broadcast completed hereunder and not paid shall become immediately due and payable. If STATION cacels by reason of AGENCY material breach, AGENCY'S only liability shall be to pay for broadcast completed hereunder prior to cancellation by STATION.
- (b) in the event of a material breach by STATION in performing this contract, AGENCY reserves the right to cancel this contract at any time upon prior notice

# FAILURE TO BROADCAST-RADIO

(a) If due to public emergency or necessity, force majeure, restrictions imposed by law, acts of God, labor disputes or for any other cause, including mechanical or electronic breakdowns, beyond STATION'S control, there is an interruption or omission of the audio signals of any commercial announcement or program contracted to be broadcast there under, STATION may suggest a substitute time period for the broadcast of the interrupted or omitted commercial announcement or program.
