## ALCOHOL AND DRUG ABUSE

Program: 4:30 & 10 P.M Date: 4/1/2015

Description: On April 1, 2015 a warrant of arrest is issued for Aaron Pena for Manufacture and/or Delivery of Controlled Substance (cocaine) a First Degree Felony and for Evading Arrest a Class "A" Misdemeanor. McAllen Police Officers conducted a traffic stop on a Tractor Trailer in the area of Conway and State Highway 107. Police Officers discovered and seized the cocaine. The weight of the cocaine is approximately 33 kilos. McAllen Police Officers are searching for Aaron Pena and seek your help in locating him. He is described as Hispanic male and is 36 years of age, approximate height 6' 1", approximate weight is 250 pounds, brown hair, and brown eyes. Length: .30

Description: Weslaco, Texas the Texas Department of Public Safety (DPS) seized more than two tons of marijuana with an estimated value of more than \$24 million after a Texas Highway Patrol trooper pulled over a tractor trailer in Starr County on Monday morning. The Commercial Vehicle Enforcement trooper stopped a 2005 Freightliner truck tractor towing a flatbed trailer for a commercial vehicle inspection on U.S. 83 west of Roma. During the inspection, the trooper discovered 174 bundles totaling 4,040 pounds of marijuana concealed inside the pressure washer skid being towed on the flatbed trailer. The driver of the truck was identified as Carlos A. Lozano, 42, of Pasadena, Texas. Lozano was arrested for possession with intent to distribute marijuana and conspire to possess marijuana. He was placed in federal custody, and the investigation continues.

Description: Brownsville, Texas U.S. Customs and Border Protection (CBP) officers at the Brownsville and Matamoros International Bridge intercepted a load of alleged cocaine valued at approximately \$35,700 during a routine examination. CBP officers discovered the alleged cocaine hidden within a reportedly stolen Jeep Cherokee. "This alleged stolen vehicle and its driver were selected for an intensive inspection which resulted in the discovery of two packages of alleged narcotics being smuggled into the country. I congratulate our officers for their outstanding work in this seizure and arrest and the recovery of this stolen vehicle," said Port Director Petra Horne, Brownsville Port of Entry. On Sunday, April 5, CBP officers working primary at the Brownsville and Matamoros International Bridge encountered a white 1993 Jeep Cherokee being driven by a man. A CBP officer conducting primary examinations referred the vehicle, its male driver, identified as a 48-year-old United States citizen who resides in Mercedes, Texas to secondary inspection for further examination after it was discovered that the vehicle he was driving was reported stolen. While in secondary, CBP officers discovered two

hidden packages within the Jeep Cherokee. CBP officers removed the packages from the vehicle which held a combined total weight of approximately 4.6 pounds of alleged cocaine.

The alleged cocaine from this seizure has an estimated street value of approximately \$35,700. CBP officers arrested the driver, seized the narcotics and turned the vehicle and its driver over to Homeland Security Investigations special agents for further investigation. Length: 1.40

Description: Pharr, TX, U.S Customs and Border Protection, Office of Field Operations (OFO) at the Pharr International Bridge arrested a man from Reynosa, Tamaulipas, Mexico after discovering \$348,160 worth of alleged cocaine within the Chrysler sedan he was driving. "Our frontline officers continue to lead the charge in CBP's effort towards keeping dangerous drugs out of our streets and ultimately from reaching and impacting our youth," said Port Director Efrain Solis Jr., Hidalgo/ Pharr/Anzalduas Port of Entry. On April 10, a 23-year-old male Mexican citizen from Reynosa arrived at the Pharr-Reynosa International Bridge driving a white 2007 Chrysler Sebring. After presenting his Mexican border crossing card, a CBP officer referred him and the vehicle for a secondary inspection and it was there that officers discovered packages of alleged cocaine weighing approximately 45.15 pounds and seized the Chrysler as well.CBP OFO arrested the man from Reynosa and subsequently released him to the custody of Homeland Security Investigations (HSI) agents for further investigation. Description: Brownsville, Texas, U.S. Customs and Border Protection officers at the Gateway International Bridge this weekend intercepted a load of alleged cocaine valued at more than \$186,660 during a routine examination. CBP officers discovered the alleged cocaine hidden within a Dodge Dakota.

"Brownsville's frontline CBP officers intercepted these 24 pounds of alleged cocaine through direct application of the outstanding training they undergo on a continuous basis. I applaud Brownsville's CBP officers for stopping these dangerous drugs from entering our country," said Port Director Petra Horne, Brownsville Port of Entry. On Saturday, April 11, CBP officers working northbound traffic at Gateway International Bridge encountered a white 1991 Dodge Dakota being driven by a man. A CBP officer conducting primary examinations referred the vehicle, its male driver, identified as a 49-year-old Mexican citizen who resides in Matamoros, Tamaulipas, Mexico to secondary inspection for further examination. A secondary inspection by CBP officers revealed 10 hidden packages within the Dakota. CBP officers removed the packages from the vehicle which held a combined total weight of approximately 24.2 pounds of alleged cocaine. The alleged cocaine from this seizure has an estimated street value of approximately \$186,660. CBP officers arrested the driver, seized the narcotics and the vehicle and turned the driver over to Homeland Security Investigations special agents for further investigation.

Description: Weslaco, Texas The Texas Department of Public Safety (DPS) seized more than 28 pounds of cocaine, worth an estimated \$1.7 million, during a traffic stop Monday evening on U.S. 281 in Brooks County. At approximately 6:35 p.m., a DPS trooper stopped a 2008 Porsche Cayenne traveling northbound on U.S. 281, south of Falfurrias, for a traffic violation. During the traffic stop, the trooper discovered 13 bundles of cocaine concealed inside a false compartment in the rear quarter panel of the vehicle. The driver, Faith Del Valle, 25, of Edinburg, was arrested for possession of a controlled substance, a first-degree felony, and booked into the Brooks County Jail.

Description: Edinburg, Texas U.S. Border Patrol agents from the Rio Grande Valley Sector arrested two convicted sex offenders and seized millions of dollars' worth of marijuana in the last 24 hours. Agents assigned to the Rio Grande City and McAllen Border Patrol stations arrested convicted sex offenders Thursday, who were attempting to enter the United States illegally. During processing, agents discovered the men, a Mexican and a Honduran national, both had previous convictions for sex crimes, including child molestation and sexual assault of a child. Additionally, agents seized more than 2,600 pounds of narcotics with an estimated value of more than \$2 million in multiple seizures Thursday. In one of the larger seizures, agents from the Rio Grande City Station were responding to narcotics smuggling activity near Garciasville when they found an abandoned GMC pickup truck. Inside the bed of the truck agents found 80 bundles of marijuana, with a weight of more than 900 pounds and a value of nearly \$740,000. Agents transported the marijuana to the Rio Grande City Station for processing. Aviation support from the Office of Air and Marine assisted in the search and seizure. Length: 1.40

On April 21, a

commercial tractor/trailer arrived at the Pharr-Reynosa International Bridge cargo facility with a manifested commercial shipment of radiator hoses. A CBP officer referred the conveyance to the vehicle non-intrusive imaging system and ultimately the shipment was sent to the secondary dock for further examination. In the process of inspecting the conveyance and shipment, officers discovered packages of suspected narcotics hidden within the batteries of the Freightliner tractor Length: 1.50

Description: ROMA, Texas Officers with U.S. Customs and Border Protection, Office of Field Operations (OFO) at the Roma Port of Entry arrested a 50-year-old man from Nuevo Leon, Mexico after discovering \$1,349,214 worth of alleged methamphetamine and heroin within the vehicle he was driving. "I commend our frontline officers for their exceptional observational skills, their attention to detail and the ability to utilize all available tools and resources," said Port Director Crescencio Cantu, Roma Port of Entry. "This interception of hard narcotics exemplifies CBP's commitment towards keeping dangerous drugs out of our communities. On April 22, CBP officers working at the Roma-Miguel Aleman International Bridge encountered a male Mexican citizen from Guadalupe, Nuevo Leon driving gold 2007 Ford Edge. A CBP officer referred him for a more thorough examination and in secondary, officers discovered packages of suspected narcotics hidden within the pickup. CBP OFO removed and seized 97 packages of alleged marijuana which carry an estimated street value of \$33,016 and seized the Chevy as well.

Description Hidalgo, Texas, U.S. Customs and Border Protection, Office of Field Operations (OFO) at the Hidalgo International Bridge arrested a 19-year-old man from McAllen, Texas after discovering 16 packages of alleged cocaine hidden within the Chevy Malibu he was driving. "Our frontline officers' continued vigilance and perseverance has enabled them to detect these hard narcotics and help keep dangerous drugs from crossing our borders," said Acting Port Director Javier Cantu, Hidalgo/Pharr/Anzalduas Port of Entry. Description: McAllen, Texas  $\hat{a} \in \bullet$  Martin Margarito-Casimiro, 28, of Camargo, Tamaulipas, Mexico, has been charged with conspiracy to commit kidnapping, kidnapping and being an alien in possession of firearms, announced U.S. Attorney Kenneth Magidson. Margarito-Casimiro was originally charged in February 2015 on the firearms charge and was remanded to custody pending further criminal proceedings. A federal grand jury in McAllen returned the super ceding indictment adding the conspiracy and kidnapping allegations today. He is expected to make his initial appearance before a U.S. magistrate judge on these charges in the near future, at which time the government will again request his continued detention. The indictment alleges that from Jan. 20 - 22, 2015, Margarito Casimiro held two individuals against their will in a residence in McAllen. The victims were allegedly bound and forced to call family members and arrange payment for their release.

Description: Falfurrias, Texas U.S. Border Patrol agents from the Rio Grande Valley Sector rescued 49 people in past 24 hours, who were concealed within several compartments of different vehicles. The drivers of the vehicles were arrested on alien smuggling charges.

The biggest rescue occurred at approximately 12:15 a.m., when Falfurrias Station agents arrested a man, who is a United States citizen, attempting to smuggle 38 undocumented aliens locked inside a tractor trailer at the Border Patrol checkpoint on U.S. Highway 281 North. Following a service K-9 alert, the driver of the trailer was referred to secondary inspection.

Two other rescues occurred on Thursday at Falfurrias checkpoint, one of which included nine people rescued from the bed of a Chevy Avalanche that was being transported on a flatbed truck. The subjects were sweating profusely due to the lack of ventilation and extremely hot temperatures. Finally, two additional people were rescued from the trunk of a car in another case.

During processing, it was discovered the men, two Mexicans and a Honduran national, had previous convictions for significant felonies, including attempt to commit sexual assault on a child, sexual assault of a child and attempt to commit homicide. Additionally, agents from the Falfurrias Station rescued seven undocumented immigrants locked in a rental cargo truck. They were discovered in a hidden compartment of the vehicle. Description: Texas to install thousands of cameras on border "This innovative use of technology has proven to be a force multiplier in detecting the smuggling attempts along the border, which is critical to interdicting criminal activity occurring between the ports of entry," said DPS director Steve McCraw in a press release. He system has been so successful that the state legislature authorized funding for 4,000 more cameras. That comes after the summer 2014 "border surge," ordered by then-governor Rick Perry to block a deluge of immigrants and refugees, failed to take a dent out of drug trafficking through the state or to raise the prices of illegal drugs for Texas consumers, VICE News reports. But the cameras could be a glimmer of hope for lawmakers fearful of what could come into the state from abroad. Pictures released by the DPS show immigrants making the treacherous trek through mostly vacant scrubland, and also drug smuggling, with men carrying large blocks of compressed marijuana on their backs or in truck beds.
