Description: Hidalgo, Texas, U.S. Customs and Border Protection, Office of Field Operations (OFO) at the Hidalgo International Bridge seized 61 pounds of alleged cocaine that was detected within a Dodge Journey driven by a man from Saltillo, Coahuila, Mexico.

"Our officers' outstanding commitment in the effort towards keeping dangerous drugs from entering through our border crossings has enabled them to intercept these hard narcotics at one of our international bridges," said Acting Port Director Javier Cantu, Hidalgo/Pharr/Anzalduas Port of Entry.

The seizure occurred on May 1, after a tan 2010 Dodge Journey arrived at the Hidalgo-Reynosa International Bridge from Reynosa, Tamaulipas, Mexico. A CBP officer referred the vehicle, and the driver, a 49-year-old male Mexican citizen after he presented his Mexican border crossing card for a secondary examination. In secondary, with the use of all available tools and resources, officers discovered 25 packages of alleged cocaine hidden within the vehicle. CBP officers removed and seized the narcotics which carry an estimated street value of \$470,560 and seized the Dodge SUV as well.

Description: PHARR, Texas U.S. Customs and Border Protection, Office of Field Operations (OFO) at the Pharr International Bridge cargo facility arrested a 33-year-old man from Reynosa, Tamaulipas, Mexico in connection with a failed drug smuggling attempt of \$385,560 worth of alleged cocaine. "Continued vigilance and alertness from our frontline officers at the cargo facility has enabled them to intercept these hard narcotics that were meticulously concealed," said Acting Port Director Javier Cantu, Hidalgo/Pharr/Anzalduas Port of Entry. "A sound enforcement posture allows us to continue detecting illicit contraband and keeping our communities safe."

Description: A South Texas officer and another man have been indicted over what prosecutors say involved fake police reports to smuggle cocaine. The federal indictment announced Tuesday names Rio Grande City police investigator Noel Pena. Prosecutors in McAllen say Pena and Hector Salinas-Hinojosa of Roma are charged with conspiracy to possess with intent to distribute as well as possession with intent to distribute cocaine. The undercover investigation began last month, leading to both men arrested. Pena was assigned to the Starr County High Intensity Drug Trafficking Area Task Force. Investigators say Pena worked with drug traffickers who would steal much of the cocaine they were holding Mexican cartels. Authorities say Pena accepted bribes to generate fake police reports saying the cocaine had been confiscated during law enforcement operations he set up.

Description: Los Arrieros, Texas U.S. Border Patrol agents from the Rio Grande Valley Sector seized more than \$1 million worth of marijuana in a single seizure Wednesday. The seizure occurred when agents assigned to the Rio Grande City Station were performing line watch duties and saw several people downriver carrying bundles of marijuana across the Rio Grande. As they approached the area, the smugglers had made landfall on the U.S. side and were walking northbound. The agents identified themselves as U.S. Border Patrol agents, at which time the smugglers abandoned more than 1,300 pounds of marijuana and fled back to Mexico.

Description: Hidalgo County Sheriff's Investigators have arrested a suspect who attempted to steal livestock last week. On Tuesday May 19, 2015 at approximately 5:00 a.m., Sheriff's Deputies responded to a home on the 9900 block of Minnesota Rd in rural Mission, Hidalgo County, TX for a report of criminal attempt theft of livestock. Sheriff's Deputies arrived and met with the victim who reported that a male suspect attempted to steal two of his sheep, but dropped

them at the gate after he could not jump over with them. Sheriff's Investigators working on the case were able to obtain surveillance video of the theft and identify the suspect. On Wednesday May 20, 2014, Sheriff's Investigators located the suspect, 25 year old Gilberto Perez Jr. in rural Mission. Pérez initially gave false information about his identity and as they attempted to arrest him, Perez began to resist causing injuries to one of the investigators. After he was taken into custody, a search of his person also revealed marijuana, cocaine, and xanax pills in his possession. Pérez was arrested on seven charges to include:

Theft, Resisting Arrest, Assault on a Public Servant, Failure to Identify, Possession of Marijuana, and two counts of Possession of Controlled Substance. Perez was later taken before a Justice of the Peace where he was arraigned on the seven charges and given a \$106,000.00 (one hundred and six thousand) total cash surety bond.

Description: On 5-26-15, at approximately 10:01pm, a Texas Department of Public Safety (DPS) Trooper attempted to stop a 2008 Toyota Prius on FM 1016 and FM 396 (south Bryan Road) in Mission, for a traffic violation. The driver of the vehicle refused to stop and began to evade law enforcement. DPS Troopers were able to deploy spikes and disabled the left front tire. The vehicle came to a stop on US 83 Frontage road and Brazos Street in Mission. Driver and occupants (all Juveniles) fled from the vehicle and ran through a neighborhood. With the assistance of U.S. Customs & Border Protection helicopter and U.S. Border Patrol ground units, the driver and 2 occupants were apprehended. A total of 29 bundle of marijuana totaling 301 pounds were found in the back of the Toyota Prius passenger car. The three juveniles were remanded to the Hidalgo Juvenile Justice Center. They were charged with possession of marijuana and evading arrest.

The driver was identified as Diaz. The officer observed that she was extremely nervous and proceeded to obtain consent to search of her vehicle for any possible contraband. The officer found five block shaped bundles in a disposable bag behind the driver's seat of the vehicle. Further investigation revealed that it was cocaine. Diaz was placed under arrest after taking full responsibility of the narcotics and charged with Possession of Controlled substance with intent to distribute. Bond was set at \$25,000

Description McAllen, Texas • Martin Margarito-Casimiro, 28, of Camargo, Tamaulipas, Mexico, has pleaded guilty to kidnapping, announced U.S. Attorney Kenneth Magidson. On Jan. 22, 2015, law enforcement responded to a man's cry for help as he ran down the street with rope still tied around his arms and legs. That victim led law enforcement to the McAllen residence where he had been held. There, law enforcement found another victim with his arms and legs bound. At that time, law enforcement discovered Margarito-Casimiro and others who were attempting to flee. During the guilty plea today, Margarito-Casimiro admitted he held at least one victim at gunpoint for ransom and directed co-conspirators to tie the victim's hands and feet. The victim was told he needed to pay in order to be released. Based on today's conviction, Margarito-Casimiro could face up to life in prison. He is set for sentencing Aug. 20, 2015, before U.S. District Judge Micaela Alvarez. He will remain in custody pending that hearing. The investigation leading to the charges was conducted by Homeland Security Investigations and McAllen Police Department. Assistant U.S. Attorney Kristen Rees and Leo J. Leo are prosecuting the case.

Investigators responded to the location and obtained consent to search the property which resulted in the discovery of approximately 699 pounds of marijuana wrapped in bundles.

Investigators arrested 20 year old Juan Gonzalez and charged him with Possession of Marijuana (2nd Deg Felony). On Saturday, Gonzalez was taken before Hidalgo County Precinct 3 Place 1 Justice of the Peace Luis Garza where he was arraigned on the charge and given a \$90,000.00 cash surety bond. Garza-Avalos made his initial appearance today in Houston, while the others appeared before Judge Ormsby in McAllen. All were ordered into custody pending their respective detention hearings. The indictment remains sealed as to those charged but not as yet in custody. All were charged in a sealed indictment returned March 11, 2015, which was unsealed upon each arrest. The indictment charges all with conspiracy to possess with the intent to distribute more than 1000 kilograms of marijuana between June 1, 2012, and the date of the indictment. Rodriguez and Elijio Perez are also charged with conspiracy to commit money laundering on Dec. 2, 2013. A third count also charges Elijio Perez with being felon in possession of a firearm on that date. Also included in the indictment is a notice that the government is seeking a personal

Description: Austin, Texas (AP) A roughly \$800 million border security package working its way through the Texas Legislature is meant to curb drug and people smuggling. But it could also attack another common enemy along the Rio Grande: Carrizo cane. The House gave preliminary approval Wednesday to a bill passed last month by the Senate. It seeks to use part of the border security package's funding to eradicate the cane, which grows along the U.S.-Mexico border. Native to Asia, Carrizo cane is common in South Texas and grows thick enough to choke water flow and obstruct border surveillance by law enforcement. The proposal would hire two state employees to help eradicate Carrizo cane at an annual cost of nearly \$199,000 in salary and benefits though more would be spent on actual eradication efforts.

Description: The tent-city prison's operator has insurance to cover at least some of Willacy County's revenue losses that stem from the prison's closure following an inmate uprising that destroyed much of the facility more than two months ago, County Judge Aurelio Guerra said. Guerra said Management & Training Corp., the company that operated the facility since it opened in 2006, has business interruption insurance that could cover the county's revenue losses for up to a year. But officials are trying to determine the length of time in which the insurance will cover the county's monthly revenue losses of about \$220,000, Guerra said. Last year, the Willacy County Correctional Center, which paid the county for every inmate it held, pumped \$2.7 million into the county's \$8.18 million general fund budget and capital fund budget. Guerra said officials plan to pull \$600,000 to \$700,000 from the county's \$5.3 million reserve fund to operate the county through the remainder of the fiscal year that ends in September.
