It is my understanding that: If the time is to be used by the candidate personally within 45 days of a primary or primary runoff election, or within 60 days of a general or same class and amount of time for the same period; where the use is by a person or entity other than the candidate or is by the candidate but outside the aforementioned 45 or 60 day periods; the above charges do not exceed the charges made for comparable use of such station by other advertisers.

I hereby acknowledge that I have read and understand the attached rate card and that I have been apprised of the station's normal and customary selling practices. I further understand that the station may, from time to time, negotiate rates other than those shown on the rate card on an individual basis according to market conditions. I further acknowledge that I understand that the station's rates for commercial advertisers may change as often as weekly and that the station reserves the right to change its rates without notice.

Political advertising purchased and aired before a lower rate is established is not entitled to a rebate. EXAMPLE: If a spot is booked, paid for and airs in week #1 and a lower rate is established for comparable time in week #2, no rebate or make good is required. Political advertising purchased but not aired before a lower rate is established will be entitled to a rebate. EXAMPLE: If a spot is booked and paid for in week #1 for airing in week #2 and a lower rate is subsequently established for comparable time in week #2, the candidate is entitled to a rebate or make good.

In the case of time purchased for use by supporters or any other non-candidates where no identifiable appearance will be made by the candidate by voice or image, the purchaser further agrees to deliver a script or transcription of the proposed broadcast to the station at least 24 hours before the scheduled time of broadcast and to indemnify and hold the station harmless for any damages or liability that may ensue from any such broadcast.

In the event that this application is accepted, I agree to abide by all provisions of the Communications Act of 1934, as amended, and rules and regulations of the Federal Communications Commission regarding such broadcasts.

This application, whether accepted or rejected, will remain available for public inspection for a period of two years as required by the rules of the FCC.
