Dear Mr. Swidler:

This is in reference to the request filed on October 19, 2020. WHYL requests a further extension of the STA granted on September 17, 2014, to continue operating from an alternate site to allow time to prepare and file the required FCC Form 301 application to propose a new permanent facility.¹ In support of the request, WHYL stated that additional time will be needed to complete measurement data exhibits and then file the application (due to loss of the licensed site in 2014).

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of STA IS HEREBY GRANTED, and WHYL may continue to operate with the following facilities:

WHYL must submit an e-mail to my attention to note the date the application was filed.
