Democratic Gov. Tom Wolf is taking another shot at a lawsuit that argues Republican lawmakers improperly bundled together five proposed state constitutional amendments to get them approved by the Pennsylvania Legislature. Wolf's new lawsuit filed late last week in Commonwealth Court is similar to the litigation he previously tried to get the state Supreme Court to take up directly, and comes less than two weeks after the justices said no but that the governor was free to sue in the lower Commonwealth Court. Wolf, whose first version was brought in July, argues that combining the five proposed amendments runs afoul of state constitutional rules that prevent bundling changes with multiple, unrelated topics.

In less than a week, New York State's new minimum requirements for concealed carry will take effect. Back in late June, the Supreme Court ruled in a 6-3 split that Americans have a right to carry firearms in public for self-defense. The vote struck down a 109-year-old law requiring New Yorkers who applied for a concealed carry permit to show to a judge "proper cause," which meant they had to distinguish themselves from other members of the community in a need for self-protection. This past week, the New York State Division of Criminal Justice Services and New York State Police released new guidelines for residents looking to obtain a concealed carry permit.

A state court is permanently blocking Gov. Tom Wolf's plan to toll as many as nine major bridges on interstates in Pennsylvania, siding with three Pittsburgh-area municipalities that argued that his administration had violated procedures in getting to the advanced stage of considering the idea. Pennsylvania Turnpike tolls will be increasing next year, the 15th consecutive year. The rules apply to all of New York's 1,800 nonpublic schools. State law requires that instruction given in a religious or other private school "be at least substantially equivalent to the instruction" at public schools.
