Sample POST-Filing Announcement

On JULY 14, 2014 (date of the last renewal grant), WCBM (station's call letters) was granted a license by the Federal Communications Commission to serve the public interest as a public trustee until SEPT 27, 2011 (license expiration date). Our license will expire on OCTOBER 1, 2019 (date). We filed an application for license renewal with the FCC. A copy of this application is available for inspection at www.fcc.gov. Individuals who wish to advise the FCC of facts relating to our renewal application, and to whether this station has operated in the public interest, should file comments and petitions with the FCC by SEPT. 1, 2019 (date, first day of the full calendar month prior to the month of license expiration).
