

On behalf of ABC Inc. and The Walt Disney Company, we would like to extend to you a retransmission consent offer for the 2012 – 2014 cycle. The retransmission marketplace continues to evolve at a rapid pace. This offer reflects the marketplace evolution and our continued support of small cable operators. However, if you are now or at any time during the term paying another top broadcast network in the market, we want to be fairly compensated and accordingly offer you two options. 
