**COMMERCIAL LIMITS AND WEBSITE RULE  
COMPLIANCE CERTIFICATION – 1ST QTR**

During the 1st quarter of 2016 (January 1 – March 31, 2016) the following Educational/Informational programs tailored to meet the requirements for teens 13 – 16 began airing March 20, 2016 on the KNDM.2/KNDB.2 – BEK 247 network. It was the intent of BEK 247 to offer the same programming in both of our DMA's and begin airing on January 3, 2016. Although our intent, we were unsuccessful in locating content that was available in both DMA's and forced to seek out separate programming for each DMA. This change alone led to many unforeseen technical difficulties in getting this content launched. BEK 247 has worked diligently over the last couple of month to overcome them and are pleased to note that we don't foresee any problems with future air dates going forward. As a result of the original programming being created for and directed at teens 13 years of age and above, the rules

(47 C.F.R. § 73.670) for commercial limits and websites do not apply.
