I, Robert A. Beizer, hereby declare as follows:

- 1. I am Secretary and General Counsel of Gray Television Licensee, LLC ("Gray Television"), the licensee of WILX-TV ("WILX"). WILX is a single station employment unit based in Onandaga, Michigan (the "Station"). This statement and relevant attachments are being submitted in response to the April 19, 2010 letter of Lewis C. Pulley, Assistant Chief of the Policy Division of the Commission's Media Bureau, concerning a random audit of the station's EEO compliance (the "EEO Audit Letter").
- 2. This Station employs more than five full-time employees as the term is defined in the Commission's broadcast EEO rule, 47 C.F.R. § 73.2080(e)(1).
- 3. In response to Question 3(a) of the EEO Audit Letter, the Station's two most recent EEO public file reports, as described in 47 C.F.R. § 73.2080(c)(6), are appended at <u>Attachment A</u>. The web address of this Station is:www.wilx.com. A copy of the current report is linked to this website. The date of each full-time hire in the Station's two most recent EEO public file reports is included in the internal business records appended at <u>Attachment B</u>.
- 4. In response to Question 3(b) of the EEO Audit Letter, documentation concerning the recruitment sources used to fill each full-time vacancy during the period covered by the above EEO public file reports is also appended at <u>Attachment B</u>. Those sources that have notified the Station that they want to be notified of job openings at the unit, as described in §73.2080(c)(1)(ii), are indicated in the job-specific documentation.
- 5. In response to Question 3(c) of the EEO Audit Letter, the internal business records appended at Attachment B provide data concerning (a) the total number of interviewees for each vacancy and (b) the referral source for each interviewee for each particular full-time vacancy filled during the period covered by the above EEO public file reports.
- 6. In response to Question 3(d) of the EEO Audit Letter, documentation concerning the unit's performance of recruitment initiatives described under § 73.2080(c)(2) during this time period is appended at <u>Attachment C</u>. Station personnel involved in the recruitment initiatives are noted in the documentation. This Station employs a total of 70 full-time employees and is located in a market with a population of less than 250,000. Accordingly, the Station is required to perform at least four recruitment initiatives during a two-year period.
- 7. In response to Question 3(e) of the EEO Audit Letter, the licensee is not aware of any discrimination complaints filed against this Station
- 8. In response to Question 3(f) of the EEO Audit Letter, the licensee affirms that the Station has created and deployed an EEO compliance plan. Further, at the corporate level, Gray Television helps ensure the importance of FCC EEO compliance is communicated to all levels within the company, including its national, regional and local personnel. In 2008 Gray Television engaged its outside communications counsel to conduct a FCC compliance training session, a significant portion of this training concerned compliance with FCC EEO rules. The

training session included written information and template forms to assist stations with compliance. In addition, outside counsel responds to requests for information and provides further guidance, as warranted. At the local level, the Station disseminates information concerning job openings broadly and undertakes valuable recruitment initiatives in the Community. The Station prides itself on the inclusiveness of its Master Recruitment Source List, which includes numerous trade organizations whose membership includes minorities and women. The Station's compliance efforts include identifying Gray Television's policy of compliance with equal employment opportunities through statements disseminated in job applications and posted in conspicuous areas within the workplace. The Station's general manager, Mike King, is responsible for overseeing EEO compliance with assistance from the Station's Manager of Human Resources, Judy Kirk.

- 9. In response to Question 3(g) of the EEO Audit Letter, the licensee affirms that the Station understands that it must periodically analyze the effectiveness of its EEO recruitment program by reviewing the productivity of sources on its recruitment lists and the outcome of its recruitment initiatives. In particular, this Station periodically reviews existing recruitment sources and seeks new sources.
- 10. In response to Question 3(h) of the EEO Audit Letter, this Station strives to comply with all federal, state and/or local laws regarding pay, benefits, seniority practices, promotions, and selection techniques and tests to ensure that the unit provides equal opportunity and does not discriminate against employees or applicants. This Station's employment practices are the ultimate responsibility of the station's General Manger, Mike King.
