## WMTJ-TV Internship Program

WMTJ-TV participates in the Internship Program with Universidad Ana G. Méndez (UAGM) - Cupey and Gurabo Campus. The internship program is for students in fields of programming, communications and public relations, engineering and production. College students are provided with an opportunity to work with the station and earn college credits for their work experience. The station provides the necessary information to the schools so that students receive earned credits and guidance under the supervision of one or several managers. During this period (October $1^{\text {st }}$, 2019 - September 30, 2020), we had 25 participants in this program.

## Students visits to Station

WMTJ-TV was part of the Financial Aid and Career Student Summit offered by Universidad Ana G. Méndez for nearly 7,000 students from public and private schools in Puerto Rico. The event provides the opportunity for high school students to learn about the academic offerings in science, engineering, business, criminal justice, culinary arts, among others, and the resources available for the teaching and learning process. Sistema TV's mobile unit provided students the opportunity to learn how the station has become a platform for academic activities and real-life experiences for students of the communications programs.

Due to COVID 19 pandemic situation, students site visits to the station were canceled.

## Training programs for station personnel

In coordination with the UAGM's Vice Presidency of Human Resources, WMTJ-TV provided trainings to their employees related to compliance, policies, benefits and the staff of the station participated in seminars designed to help the station to improve their performance
