As you know, the FCC has permitted our broadcast stations to count as "core" otherwise core children's programs that they preempt for live carriage of Network sports provided that the children's program is rescheduled for a substitute time slot with appropriate notifications of the schedule change made both on air and to program guides. The on-air notification must announce the alternate date and time when the preempted show will air and can utilize video graphics, with or without an audio complement. You may choose to make these preemption announcements during the legally required top-of-the-hour four-second station call letter/community of license identification.

Based on the contemplated live network feeds of children's "core" education programs and live Network sports preemptions surrounding ABC's live coverage of sports, I recommend that you make the following preemption announcements due to ABC's live coverage of the Buffalo Wild Wings Citrus Bowl that will be broadcast on Saturday, 12/31/16 (modified as needed to reflect local scheduling differences):

Saturday, December 31, 2016:

Mountain Time Zone

- At 9:00AM during the Buffalo Wild Wings Citrus Bowl: "Rock the Park will air on Sunday, January 1st at 10:30AM."
- At 9:30AM during the Buffalo Wild Wings Citrus Bowl: "Outback Adventures w/Tim Faulkner will air on Sunday, January 1st at 11:00AM."

Sunday, January 1, 2017:

Mountain Time Zone

- At the end of Rock the Park (10:00AM): "Rock the Park will return next Saturday, January 7th at 9:00AM."
- At the end of Outback Adventures w/Tim Faulkner (10:30AM): "Outback Adventures w/Tim Faulkner will return next Saturday, January 7th at 9:30AM."
