Dear Mike,

The letters announcing the intention of WLFG and WAGV to begin testing and/or broadcasting on their new channel were mailed on October 31, 2018 and November 15<sup>th</sup> 2018 to a total of 292 medical facilities within an eighty mile radius of the main transmitter site (please note that while the proofs of mailing indicate 294 letters, two of them were control letters we send to ourselves at RFN).

Enclosed is a copy of the Medical Notification Letters, a list of the addresses, and the proof of mailings stamped by the US Post Office in Orlando, Florida.

RF Notifications will store the undeliverable letters returned by the USPS until six months after Phase 2 is complete. If at any point you would like the letters returned, please let us know and we will send them to you. Please note that the average return rate is generally eight to ten percent and letters are typically returned due to: the facility relocating and forwarding has expired, the name was changed, the facility refused to accept the letter, or the operation merged with, or was acquired by another company.

The returned letters along with the total list of facilities notified and the proof of mailing will be evidence of your sincere attempt and good faith effort to identify and notify health care operations in your coverage area. Please place these documents in your Public File.

In closing, it has been a pleasure to serve you and your station, and I look forward to helping you with any other notification needs in the future.

THIS LETTER CONCERNS TELEMETRY OPERATION. THE RESPONSIBLE PARTY FOR OVERSEEING AND/OR MAINTAINING CLINICAL OR BIOMEDICAL ENGINEERING EQUIPMENT AT THIS FACILITY MUST RECEIVE THIS LETTER.

Dear Administrator or Biomedical Engineer,

WLFG AND WAGV have retained RF Notifications, a broadcast TV consultant, to notify you of the impending change of the Station’s digital television channel in your area.

We are notifying you of this channel change because patients at your facility may use biomedical telemetry devices that operate in the television broadcast band and may be affected when this change takes place.

As early as March 01, 2019, WLFG and WAGV will begin testing their new DTV broadcast transmission equipment on UHF channel 14. This testing is in preparation for full time operations on channel 14 to commence on or about April 12, 2019. During this testing phase these Station’s current channels will remain on-air.

Certain biomedical telemetry devices have been allowed to use unoccupied TV channels in their area on a secondary basis, according to the rules of the Federal Communications Commission (codified at 47 CFR 15.242 (a)(1)). If interference to or from these devices arises with regard to the TV broadcast service, the devices must cease operation on that channel. It is the responsibility of the medical facility or operator of the device to identify and retune its equipment to an alternative non-interfering channel.

The purpose of this letter is to provide you information and give you reasonable opportunity to resolve any issues. It will be important for you to discuss these changes with your technology supplier, especially if there is a possibility that biomedical devices used in your facility are likely to malfunction when WLFG and WAGV change their TV channel operations. If you plan to replace your biomedical equipment, we urge that you purchase equipment designed to operate in the frequencies set aside for medical use.

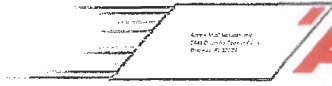

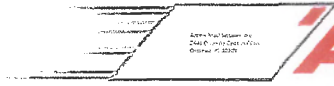
