From time to time, KDLH broadcasts CBS network programs in additional time slots, including news, sports, pre- and post-game shows, and awards programs.

FCC rules prevent local cable systems from carrying the signal of any other television station when such other station broadcasts CBS programming. If your cable system has been honoring KDLH's network exclusivity rights, we thank you for your cooperation and request that you continue these efforts through the duration of our affiliation agreement. Gentlemen:

Reference is made to the CBS Television Network Affiliation Agreement ("the Agreement") dated July 1, 1995, as amended, between you and us relating to broadcast station KDLH-TV in Duluth, Minnesota.

This will reiterate and reconfirm the network program non-duplication protection for your station as specified in Paragraph 9 of the Agreement:

"9. Non-Duplication of Network Programs.

(a) For purposes of this paragraph, a television station's "Network Exclusivity Zone" shall mean the zone within thirty-five (35) miles of the station's reference points, or, in the case of a "small market television station," as defined in Section 76.92 of the FCC rules, the zone within 55 miles of said reference points; provided, however, that in no case shall the "Network Exclusivity Zone" include an area within the Designated Market Area ("DMA"), as determined by A.C. Nielsen Company, of another CBS Television Network Affiliate. A station's "reference points" for purposes of this paragraph shall be as defined in Section 73.658(m) of the FCC rules, and shall be deemed to include, with respect to a station in a hyphenated market, the reference points of each named community in that market.

(b) Broadcaster shall be entitled to exercise, within Affiliated Station's Network Exclusivity Zone, the protection against duplication of network programming, as provided by Sections 76.92 through 76.95 and Sections 76.120 through 76.122 of the FCC's rules, with respect to a Network Program during the period beginning one (1) day before and ending seven (7) days after the delivery of such Network Program by CBS to Broadcaster; provided, however, that such right shall apply only to Network Programs broadcast in the live time period as offered or on no more than a one day delay as accepted by CBS; and provided further that nothing herein shall be deemed to preclude CBS from granting to any other broadcast television station licensed to any other community, similar network non-duplication rights within that station's Network Exclusivity Zone, and Broadcaster's aforesaid right of network non-duplication shall not apply with respect to the transmission of the programs of another CBS affiliate (current or future) by a "community unit," as that term is defined by the rules of the FCC, located (wholly or partially) within the area in which Broadcaster's Network

Exclusivity Zone overlaps the Network Exclusivity Zone of that other CBS affiliate.

(c) Broadcaster's network non-duplication rights under this paragraph shall be subject to cancellation by CBS on six (6) months written notice to Broadcaster. Any such cancellation by CBS shall not affect any of the other rights and obligations of the parties under this Agreement."

Paragraph 9 of the Agreement is hereby re-confirmed, and all other terms and conditions of the Agreement remain in full force and effect.



Re: Grant of Non-Duplication and Syndicated Exclusivity Rights

Malara Broadcast Group of Duluth LLC d.b.a. KDLH/KBIR/KRII ("Broadcaster") has offered and The CW Network, LLC ("The CW") has accepted terms under which Broadcaster has become an affiliate of The CW and have the right to telecast all programs made available by The CW in any and all formats as part of the program service currently known as "The CW Plus". As a part of The CW Plus, The CW will provide the programs of The CW Network ("CW Network Programs"), which will be subject to the protection against duplication of programming as set forth below, and syndicated programs, listed on the attached Appendix A, which will be subject to the grant of syndicated exclusivity as set forth below ("CW Plus Programs").

During the period beginning one day before and ending seven days after the day The CW intends for any CW Network Program to be broadcast by The CW's broadcasters, Broadcaster shall, by the terms of this contract, be entitled to invoke, with respect to that CW Network Program, throughout the maximum geographic zone permitted by 47 C.F.R. §73.658(m) and 47 C.F.R. §76.92 and §76.120(e), as those rules exist as of the date of this Agreement ("Network Exclusivity Zone"), the protection against duplication of programming in any and all formats imported under the Statutory Copyright License, as provided by 47 C.F.R. §76.92 through §76.95 and 47 C.F.R. §76.120 through §76.124 (the FCC's cable and satellite network non-duplication rules); provided, however, that such right will apply only to CW Network Programs broadcast in the intended time period or authorized make-good time period; and provided further that nothing herein will be deemed to preclude The CW from granting to any other broadcast television station licensed to any other community similar network non-duplication rights within that station's Network Exclusivity Zone. Broadcaster's aforesaid right of network non-duplication





will not apply with respect to the transmission of the programs of another CW broadcaster (current or future) by a community unit or a satellite carrier, as those terms are defined by the FCC, located (wholly or partially), or serving subscribers within the area in which Station's Network Exclusivity Zone overlaps the Network Exclusivity Zone of that other CW broadcaster.

Broadcaster shall, by the terms of this contract, be entitled to invoke the protection against duplication of programming imported under the Compulsory Copyright, as provided in the FCC's cable and satellite syndicated exclusivity rules (§76.101 and §76.123) of the FCC rules) for the CW Plus Programs indicated in Appendix A.

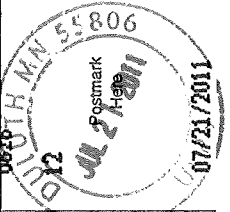
