Re: Carriage of KAID(TV)/DT, Boise, Idaho, serving the area including Mountain Home, Idaho; KCDT-TV/DT, Coeur d'Alene, Idaho, serving the area including Bonners Ferry, Idaho; and KUID-TV/DT, Moscow, Idaho, serving the area including Moscow, Idaho

Dear Mr. Evard:

State Board of Education, State of Idaho, licensee of KAID(TV)/DT, Boise, Idaho, serving the area including Mountain Home; KCDT-TV/DT, Coeur d'Alene, Idaho, serving the area including Bonners Ferry; and KUID-TV/DT, Moscow, Idaho, serving the area including Moscow, which operate as Idaho Public TV hereby responds to your letter concerning your acquisition of certain cable systems and continued carriage of KAID(TV)/DT on the cable system serving Mountain Home, Idaho, and surrounding areas, and the continued carriage of KCDT-TV/DT on the cable systems serving Bonners Ferry, Idaho, and the continued carriage of KUID-TV/DT on the cable systems serving Moscow, Idaho, and the surrounding areas.


Idaho Public TV initially notes that the referenced cable systems, as well as KAID(TV)/DT, KCDT-TV/DT, and KUID-TV/DT, are currently parties to the retransmission consent agreement negotiated by NCTA and PBS. That agreement includes language which provides that the agreement shall bind and inure to the benefit of each party's successors and assigns. We thus would contend that the existing agreement is or will be binding upon Windjammer Communications LLC as a successor or assignee.

In any event, however, KAID(TV)/DT, KCDT-TV/DT, and KUID-TV/DT are entitled to mandatory carriage on the cable systems in question. Each station is a qualified, local, noncommercial educational station in its respective market, as the Grade B contour of KAID(TV)/DT covers the principal headend of the Mountain Home system, and the Grade B contour of KCDT-TV/DT covers the principal headend of the Bonners Ferry and the Grade B contour of KUID-TV/DT covers the principal headend of the Moscow systems. Accordingly, Idaho Public TV claims its continued right to carriage of KAID(TV)/DT on the Mountain Home and surrounding areas systems, of KCDT-TV/DT on the Bonners Ferry and surrounding areas systems, and of KUID-TV/DT on the Moscow, and surrounding areas systems.
