Amendment to Previously Filed Children's Reports

Ramar Communications, Inc., licensee of KRTN-TV, Durango, Colorado (the "Station"), seeks to amend the quarterly Children's Television Programming Reports listed below (the "Reports") to correct an inadvertent error in the children's programming reported for the Station digital programming stream displayed to the public as Channel 33.1. By mistake, these Reports as originally filed listed for the Station's stream the broadcast of children's programming that is provided as part of the MOVIES! TV Network. KRTN-TV had previously carried MOVIES! Network programming on the 33.1 stream. However, during the calendar quarters that are the subject of the Reports, the Station had switched from MOVIES! to the CHARGE! TV Network. Accordingly, by this document, Ramar amends the Reports to report the children's programming provided by the CHARGE! TV Network, as actually carried on the 33.1 stream during each reported calendar quarter. Ramar notes that it satisfied its core children's programming obligations during the reported quarters, but made an inadvertent reporting error. It is now correcting that error, upon its discovery.

Program Information:

Each program was 30 minutes in length, and the age of target child audience was 13 years to 16 years old. Ramar identified the program by displaying throughout the program the symbol E/1. Descriptions of the educational and information objective of each program, and how it meets the definition of core programming is below:

Sports Lab:

"SPORTS LAB" serves the educational and informational needs of children 13 to 16 years of age with its program content, including the importance of understanding the science behind various sports. The series examines many different sports and explores what are the scientific parameters of each individual sporting activity.

Get Wild:

"Get Wild" serves the educational and informational needs of children 13 to 16 years of age with its program content. "Get Wild" is a weekly half-hour reality series featuring wild animals at the world famous San Diego Zoo. The series provides key information about each creature and teen viewers learn about their living habitats and unique behaviors. For example, in one episode viewers learn how experts studying adult orangutans learn the ways they raise their young. Another episode highlights the Panda bear and explains the animal's living patterns. "Get Wild" is a series intended to educate and inform viewers all about life in the animal kingdom.

"Wild World" is a weekly half-hour reality series showcasing all types of wild animals at the world famous San Diego Zoo. The series focuses on the dedicated people who care for these unique critters. The program also informs teen viewers about the living environments and key facts about each wild animal. Episodes also include stories on zoo enrichment programs that help animals initiate natural behavior. Whether it be following the life cycles of rhinoceros or understanding the eating habits of grizzly bears, "Wild World" is a series intended to educate and inform viewers all about life in the animal kingdom. "Wild World" serves the educational and informational needs of children 13 to 16 years of age with its program content.

The Re-Inventors:

"THE RE-INVENTORS" serves the educational and informational needs of children 13 to 16 years of age with its program content, exploring historic inventions and testing them. The series examines the original patent information, including blueprints, then, along with additional tradesmen as needed, build the prototypes, and test each of these, often strange, inventions to see if any could actually succeed.

Uncaged:

"UNCAGED" serves the educational and informational needs of children 13 to 16 years of age with its program content, including exploring the world of various wild animals and the importance of understanding these wild critters in the animal kingdom. The series travels around the world to learn about different species and their habitats.

DragonFly TV Sports:

"DRAGONFLY TV SPORTS" features stories of children "doing" projects with real hands-on experience and demonstrates practical applications of mathematics and science, in particular, as it relates to individual sports or sporting activity. "DRAGONFLY TV SPORTS" serves the educational and informational needs of children 13 to 16 years of age with its program content.
