


**CHILDREN'S PROGRAMMING CERTIFICATION**  
(Fourth Quarter 2016)

This is to certify that the list below identifies all programs and series considered as children's programming under the Children's Television Act of 1990 (the "Act") aired by ABS-CBN INTERNATIONAL's television programming service known as The Filipino Channel for the period beginning October 1, 2016 to December 31, 2016. As a standard practice, we formatted and aired each of the children's programs and series so that the total commercial time (including local avails, promos for non-educational programs and adjacent ads running before or after the program within the same clock hour) did not exceed 10.5 minutes per hour on weekends, and 12 minutes per hour on weekdays, in compliance with the Act and the rules and regulations of the Federal Communications Commission (FCC). None of the following programs or series included any commercial spots that contained references to, characters or actors from, or that offered products related to, the underlying program or series.




