

POST-FILING ANNOUNCEMENT

On March 24, 2006, Station WWWA(FM), Winslow, Maine, was granted a license by the Federal Communications Commission to serve the public interest as a public trustee until April 1, 2014. On April 3, 2012, Station WWRN(FM), Rockport, ^{Massachusetts} ~~Maine~~, was granted a license by the Federal Communications Commission to serve the public interest as a public trustee until April 1, 2014. On May 17, 2011, Station WFYB(FM), Fryeburg, Maine, was granted a license by the Federal Communications Commission to serve the public interest as a public trustee until April 1, 2014. On January 24, 2013, Station WMEY(FM), was granted a license by the Federal Communications Commission to serve the public interest as a public trustee until April 1, 2014. On January 6, 2012, Station WRPB(FM), Benedicta, Maine, was granted a license by the Federal Communications Commission to serve the public interest as a public trustee until April 1, 2014.

Our licenses will expire on April 1, 2014. We have filed an application for renewal for each station with the FCC. Copy of these applications are available for public inspection during our regular business hours. The applications contain information concerning the stations' performance during their license term. Individuals who wish to advise the FCC of facts relating to the renewal applications and to whether the stations have operated in the public interest should file comments and petitions with the FCC by March 1, 2014.
