- 2 Pursuant to MM Docket 87-267, after the 5 year period starting from the date the facility specified herein is initially licensed, licensee will surrender either the expanded band license or its existing band license.
  
- 3 Ground system consists of 120 equally spaced buried copper radials about the base of each KCKK except when terminated by property boundaries or where intersecting radials are shortened and bonded plus a 9.8 m by 9.8 m ground screen at the base of each tower.
