- 2 Educational Media Foundation requests waiver of 47. C.F.R. Section 73.1125 to operate the proposed facility as "satellite" of co-owned noncommercial educational FM station KLVR(FM), Middletown, CA (Facility ID No.: 18801). Based upon the specific representations contained therein, the waiver request IS GRANTED. Applicant shall abide by each representation proffered in the waiver request.
- 3 The licensee has demonstrated compliance with the FCC radiofrequency electromagnetic field exposure guidelines based upon the usage of the antenna specified herein. If the licensee makes any changes in facilities via modification of license application in accordance with 47 CFR section 73.1690(c), the subsequent Form 302-FM, application for license, must include a revised RF field showing to demonstrate continued compliance with the FCC guidelines.
- 4 Further modifications to the facilities of station KFSR(FM), Fresno, CA., (Facility ID No. 8349), will not constitute as a per se modification of KLVY authorization. (See 'Educational Information Corporation 6 FCC Rcd 2207 (1991)).
