- 3 Houston Christian Broadcasters, Inc. requests waiver of 47 C.F.R. Section 73.1125 to operate the proposed facility as a "satellite" of co-owned noncommercial educational FM station KHCB-FM, Facility ID#27702, Houston, TX. Based upon the specific representations contained therein, the waiver request IS GRANTED. KRTG shall abide by each representation proffered in the waiver request.
- 4 Pursuant to 47 C.F.R. Section 73.202 (a) (1) (ii) and its required levels of first and second NCE service, the permittee/licensee is required to construct and operate with substantially the same technical facilities under which the allotment qualified for reservation solely for noncommercial educational use.
